## **POLITICAL HOTSPOT**

On a surprise-meant-to-be-Christmas-gift trialogue that took place on 19 December 2018, the three European institutions reached a final agreement on the Unfair Trading Practices (UTPs) directive [1]. In a <u>press release</u> published by IFOAM EU on 19 December, President Jan Plagge welcomed this directive and the strong political commitment towards seeking to improve the position of weaker actors against UTPs. He added that "a minimum harmonized standard at EU level was needed on the issue of unfair trading practices" and hoped that "adequate collaboration between Member States competent authorities will make sure that this directive is adequately enforced".

The legislative text was proposed by the European Commission in April 2018 to counteract the fact that "micro, small or medium suppliers are particularly vulnerable to unfair trading practices and least able to weather them without negative effects on their economic viability". While the AGRI committee was lead negotiator in the Parliament, also three other committees – IMCO, ENVI and DEVE – voiced their opinion on the content of this legislation given its importance.

<u>IFOAM EU published a position paper on the matter</u> and collaborated with other NGOs such as Oxfam, Traidcraft and Fair Trade in order to advocate for a fairer and more far-reaching proposal. The two most contentious issues were the scope in terms of actors covered by the directive and the list of prohibited UTPs. The final text includes most of the points that IFOAM EU had advocated for along with other NGOs, which ensure a greater protection of the most vulnerable actors in the food supply chain than initially proposed. Main points of the final text are:

- The scope in terms of actors covered has been extended to suppliers up to a turnover of 350 million EUR. Suppliers are grouped into five categories based on annual turnover in million EUR (0-2; 2-10; 10-50; 5-150; 150-350). Suppliers are protected only if the buyer fits into a larger category; suppliers are not protected from buyers of the same category;
- The list of prohibited UTPs has been extended from 8 to 15 and includes e.g. short notice cancellation of orders (less than 30 days), unilateral changes to the supply agreement, requiring a supplier to pay for the costs of customer complaints;
- The right to file a complaint has been extended to organisations with a legitimate interest in representing suppliers, and not only to producers' organisation;
- A review clause has been included, the review period being of 4 years.

The European Parliament is set to vote on the final proposal in the second March plenary, and the final directive should be published in the Official Journal by May, prior to the end of the current legislature. The transposition period for publishing the national law is 24 months; 30 months for that law coming into force.

## 1.1 Policy

#### **Organic regulation**

## **New Regulation on Organic Imports published**

A new update of the 'Organic Imports' Regulation (EC) No 1235/2008 has been published in January. New Regulation (EU) 2019/39 updates the list of Equivalent Third Countries (Annex III) and the List of Control Bodies and Authorities which operate in Third Countries and are recognised for the purpose of equivalence (Annex IV).

Updates concern different kind of information, from names, addresses or internet addresses of Competent Authorities and Control Bodies to extension of the geographical scope of Control Bodies (it means that they are authorised to certify in additional Third Countries), but also the withdrawal from the list or the suspensions of Control Bodies.

#### **CAP**

#### Work speeds up on the post-2020 CAP revision

The EU co-legislators continue to work on the CAP revision for the 2021-27 programming period, stepping up the pace ahead of the upcoming European elections.

The European Parliament appears to be moving faster on the main CAP Strategic Plans file within the two key Committees in charge: Agriculture and Environment. Following the deadlines for amendments of last December when thousands of changes were proposed by parliamentarians, the lead Rapporteur and Shadow MEPs have been meeting weekly to find compromises on the proposed changes to the Commission's proposal. It is expected that the Environment Committee will vote on the dossier on 14 February and the Agriculture Committee in early March. A vote on CAP by the whole Parliament in plenary would be possible by April, although this remains unlikely. Following the May elections and the appointment of MEPs to Committees, it is expected that work on the CAP will resume after the summer break. The new Parliament can decide to either continue where the current legislature left off on CAP, take parts of work or start from scratch.

The Council of the EU is advancing on the file and the Romanian presidency hopes to have a provisional agreement among Member States by the end of its presidency in June 2019. The Finish presidency taking place during the 2<sup>nd</sup> half of 2019 is expected find a final agreement in Council on outstanding CAP provisions as well as on the EU budget.

It is likely that CAP negotiations between Council and Parliament will be ongoing at the end of 2019 and continue into 2020. IFOAM EU will continue to follow the CAP negotiations and advocate for a policy focused on rewarding farmers for the delivery of public goods.



## Maximising the Common Agricultural Policy's (CAP) environmental benefits by using eco-schemes

On 30 January the researchers of the Institute for European Environmental Policy (IEEP) published <u>'CAP 2021-27: Using the eco-scheme to maximise environmental and climate benefits'</u>. The publication examines the eco-scheme proposal assessing the opportunities and risks of the new intervention as well as identifying what is needed to ensure that it reaches its full potential. It provides concrete recommendations on how to make the most of the CAP's green architecture with the aim to mainstream sustainability in farming, using the Commission's CAP proposal of June 2018 as basis, and drawing on the experiences of past reforms of the policy.

This publication comes at a crucial moment in the CAP negotiations to establish the next farmers support programme in the EU for the period 2021-27. Read the full report and the reactions on its main conclusions.

The report was produced by the Institute for European Environmental Policy (IEEP) and commissioned by IFOAM EU. To follow-up on this report, IFOAM EU and a team of researchers are working on a practical guide on how Members States can design Eco-schemes in the CAP strategic plans during the implementation phase of the policy.

## 1.2 Food, farming and environment

#### The European Patent Office re-opens the possibility to grant patents on life

On 5 December 2018, the Technical Board of Appeal of the European Patent Office (EPO) <u>took a</u> decision aimed at maintaining the possibility to patent plants and animals.

This move contradicts the EPO's decision of June 2017, amending two articles (Art. 27 (b) and 28) of the Implementing Regulation to the European Patent Convention to exclude plants and animals resulting 'exclusively' from essentially biological processes from patentability. In line with the Commission's legal interpretation, the amendments to these articles clarified that plants and animals obtained from conventional breeding, not involving genetic engineering, are excluded from patentability. IFOAM EU welcomed this decision as a first step to avoid patent on life in accordance with the letter and the spirit of the <u>Directive 98/44/EC</u> on the legal protection of biotechnological inventions.

However, in its recent decision, the Technical Board of Appeal of the EPO took a step back, considering that the new article 28 is 'in conflict' with article 53(b) of the European Patent Convention.

This decision is astonishing, as by modifying article 28, the 38 member countries wanted to leave no room for interpretation. That is why the civil society collation 'No Patent on seeds' calls for a moratorium of patents on plants and animals until the 38 Countries Member of the EPO discuss this decision which is in direct contradiction with their position.

IFOAM EU will continue to follow these discussions which could have serious consequences on the freedom of farmers and consumers closely.



## Help us to protect our water! - Act NOW

The European Commission is currently reviewing the Water Framework Directive (WFD) which is the key instrument to protect water bodies like rivers, lakes and ground water. Since the ambitious legislation has been adopted in 2000, it has contributed substantially to the improvement of European water bodies. Therefore, IFOAM EU supports the <a href="Protect Water">Protect Water</a> campaign which was initiated by a broad coalition of NGOs to maintain the high level of environment protection and to defend a strong policy on water in the EU.

It's no secret that the agri-food sector contributes to a large share of water consumption and contamination. However, organic production improves the quality of water bodies, by implementing sustainable water management. This includes the use of agronomic practices such as crop rotations and cover crops - shown to reduce nutrient leaching and run-off into water bodies. Moreover, a strong emphasis on soil structure and increased humus quality makes organic production well placed to enhance water-holding capacity, resulting in an increased resilience to extreme climate events such as heavy rainfall and droughts.

#### Final report on pesticide authorisation published by European Parliament's Special Committee

After nine months of work in the EU Parliament's Special Committee on pesticide authorisation in the European Union (PEST committee), a <u>final report</u> was adopted by a large majority in the plenary on the 16 January 2019.

The report calls for a more transparent, independent and scientifically sound assessment of plant protection products. It will feed into the evaluation of the European pesticide authorisation system (<u>REFIT Evaluation</u>) which is currently performed by the European Commission and expected to be finalised in the first half of 2019.

The organic movement welcomes the fact that the report acknowledges the difficult situation for products of natural origin, such as biological substances used in organic farming. Especially the point that data requirements are made for synthetic substances and the need for an adapted authorisation and registration process is very welcomed. Furthermore, the need to research alternatives for plant protection products, including non-chemical methods and the research of agroecological farming methods was mentioned as essential future strategy.

The PEST Committee was established in February 2018 following the controversaries of the re-approval of Glyphosate. IFOAM EU actively followed the Committees work and had several exchanges with its members.

Organic farmers are working with nature to grow food in healthy soils by avoiding the use of chemicals that deteriorate the delicate ecosystem. In this way, this practice encourages wildlife growth, with organic farms being home to 30% more species than conventional farms. By using compost wisely, organic farmers are also preserving aquatic ecosystems by keeping them safe from chemical runoff which contaminates oceans, rivers and lakes.

#### Beyond the CAP: what does a Common Food Policy look like according to IPES-Food?

"A common food policy for Europe is urgently required to address climate change, halt biodiversity loss, curb obesity, and make farming viable for the next generation". This was the key message of a <a href="mailto:press statement">press statement</a> released on 7 February 2019 by IPES-Food to launch their vision and report on a common food policy at EU level. <a href="Read the full report">Read the full report</a>.

The vision for a common food policy is the result of a three-year process of research led by the International Panel of Sustainable Food Systems (<a href="IPES-Food">IPES-Food</a>) and its co-chair, Olivier de Schutter, former UN special rapporteur on the right to food. IFOAM EU has contributed to this vision along with about 400 other stakeholders, ranging from scientists to farmers and civil society activists.

The report puts forward 80 concrete proposals divided between short-, medium- and long-term reforms. Proposals include a new governance structure to break down policy silos, e.g. by creating a food intergroup in the European Parliament, as well as introducing an EU-wide 'agroecology premium' as a new rationale for CAP payments.

The results will be reflected in dynamic scientific and policy panel discussions with leading experts and representatives from the European Commission, the Food and Agriculture Organization of the United Nations (FAO) and European Parliamentary Alliance for the Fight Against Hunger in view of the role of organic agriculture and other agroecological approaches in European and international development policy frameworks in the context of the 2030 Agenda for Sustainable Development.

## **Ensuring an organic & fair Europe: IFOAM EU and Fair Trade will collaborate on European elections** May 2019

In the spirit of their long history of collaboration, the organic and fair trade movements have decided to team up to raise the awareness of candidates for the European elections on the responsibility of the next European Parliament to transform our production and consumption models towards sustainability.

The networks involved, including development organisations and proponents of the social economy, will prepare tools for their national members that they can use to approach candidates and discuss their visions for Europe. Rather than a full-blown campaign, this is a light approach aimed at making possible quality discussions with politicians who are not necessarily "natural" supporters of organic farming or fair trade. This will be a good opportunity for IFOAM EU's members to cooperate with the fair trade movement at the national level and we count on your active involvement in the coming months!

#### 3.2 Review of events

## Biggest tractor demonstration at German Green Week

On 19 January more than 35.000 people marched in front of Berlin's Brandenburger Gate under the motto "Wir haben es satt", or "We are fed up". Demonstrators braved the cold to demand from the German Agricultural Minister and the EU for a reformed Common Agricultural Policy (CAP) that is good for farmers, animals and the planet. The march was organised during Berlin's Green Week, a high-level yearly event that brings together agricultural ministers and business leaders from across the world to discuss food and farming.

Organic farmers were well represented in the march, coming from across Germany and gathering a record-breaking 171 tractors at the heart of Berlin. Together with civil society organisations they have asked for a CAP that stops support for factory farming and instead uses this public money to encourage farmers to protect biodiversity, regenerate the environment and support rural communities.

In addition to its advocacy work in Brussels, IFOAM EU supports mass mobilisation on CAP under the platform goodfoodgoodfarming.eu.

## IFOAM EU's Interest Group of Organic Retailers meets, and visits specialised organic retailers in Berlin

The newly established IFOAM EU Interest Group for Organic Retailers (IGOR) met in Berlin for their second official meeting on 17 and 18 January. The first part of the meeting was dedicated to identifying



the specific characteristics shared by specialised organic retailers all over Europe, to how to work together, and to defining a working program for the next months. IGOR members are particularly interested in exchanging about best practices that highlight the strengths of specialised organic retailers.

After a lovely dinner, the group was ready the next day to visit different types of organic specialised shops. Finally, the group visited the Green Week before travelling back to their home countries.

The IFOAM EU IGOR plans to meet again in Paris in October in conjunction with Natexpo, the international trade show for organic products.

## Mobile slaughter: An alternative to long distance animal transport

On 23 January, the European Parliaments' Agricultural Committee voted on a report on animal transport within and outside the EU. The report concludes that the existing legislation is not sufficiently applied, especially regarding the minimum requirements for animal's fitness for transport and the duration of transport. The attempt of some parliamentarians to limit the maximum time for transport of life animals was nevertheless rejected.
