# **WELCOME NOTE**

On 20-21 June, European and national policy-makers and the organic community will gather in Bucharest, Romania, for the European Organic Congress 2019. The theme of this year's edition is "Innovation and technology: how organic improves, inspires & delivers".

On 20 June, we will talk about improving agricultural policies. The first part of the day will focus on a policy crucial for all organic farmers in Europe: the Common Agricultural Policy (CAP). Petre Daea, Minister of Agriculture and Rural Development of Romania and I will welcome you. After our welcome, we will be joined on stage by policy-makers and representatives of civil society. Pierre Bascou, Director Sustainability and Income Support at the European Commission's Directorate General for Agriculture and Rural Development and Aard Mulders, Senior Advisor at the Ministry of Agriculture, Nature and Food Quality of The Netherlands will join Minister Daea as key policy-makers. Luc Bas, Director of the International Union for Conservation of Nature (IUCN), Joachim Rukwied, President of the Committee of Professional Agricultural Organisations (COPA), Tiberiu Cazacioc, Member of Expert Group on CAP at Slow Food and Aina Calafat of the Spanish Society of Organic Agriculture (SEAE) will represent civil society. Our panel will address specific questions like, does the CAP's new Green Architecture work for the benefit of farmers, consumers and rural communities? How can organic farmers contribute towards CAP objectives under the policy's New Delivery Model? Can Europe do more with less budget to support its farmers and what can be done about it? We will continue the congress with a plenary on a new European organic action plan for 2020-2027, and sessions on the secondary legislation following the organic regulation.

On day two of the conference we will shift our focus to innovation and technology. At IFOAM EU we have been working on a scoping paper on emerging technologies. We identified technologies that are the most relevant for and their impacts on the organic sector, such as robotics, drones, internet of things (IoT), artificial intelligence, blockchain and gamification. Our paper also investigates trends that have developed as a result of the increased presence of technologies in the agricultural sector. It seems that many technologies are not affordable nor particularly useful for small and medium size farms. They seem to be mostly developed for large scale, capital-rich farms by using a top down approach. We invite you to join us at the European Organic Congress 2019 to discuss these first findings in-depth. With your input we will further corroborate this paper.

I'd like to invite you to join us and explore what organic can gain by using emerging technologies and improvements beyond organic. Read all about the interactive session and the workshops we will have on the European Organic Congress' website. Moreover, I'd like to thank Bio Romania and the Romanian Ministry of Agriculture and Rural Development for helping us organise the Congress, and our sponsors and media partners to help make it possible!

#### **POLITICAL HOTSPOT**

The elections of new Members to the European Parliament took place 23-26 May. As IFOAM EU we want to thank all the European citizens in 28 Member States who voted. We also extend our congratulations to the candidates that were elected. We wish them all the best for the five year to come and are looking forward to working together with the Committee on Agriculture and Rural Development (AGRI), the Committee on Environment, Public Health and Food Safety, the Committee on Industry (ENVI), Research and Energy (ITRE), and other committees on all issues related to organic agriculture.

In the coming months, the political parties of the European Parliament (MEPs) will nominate candidates for the role of Commission President – so-called 'Spitzenkandidat'. The party with the most seats – the European People's Party according to the provisional results – will receive the first opportunity to attempt to form a majority in the Parliament to back their candidate – Manfred Weber. Following the election of the Commission President, the Commissioners are proposed by the Council of the European Union, based on suggestions made by the national governments. Afterwards, the European Council appoints them, and the European Parliament approves them. The new Parliament and Commission will be in office by around June and October respectively. Have a look at the European Parliament's infographic visualising the process.

The representatives of the European citizens face many challenges. Climate change, water scarcity, and biodiversity loss to name a few. Citizens acknowledge this by purchasing more organic. Organic production and consumption have been growing for three decades. In 2017, the total land area under organic management in the EU was 14.5 million hectares compared to 11.4 million hectares in 2012. This goes hand in hand with a significant growth of the EU organic retail market, increasing from €22 billion in 2012 to €37 billion in 2017. There are now 460.000 organic farmers in the EU, representing an increase of 70% since 2007.

As the organic movement we believe that it is of vital importance that the elected officials are aware of the importance of organic's contribution to a better world. Recent studies like the <u>modelling exercise of the Institut du Développement Durable et des Relations Internationales (IDDRI)</u> shows organics' contribution to climate change mitigation and biodiversity conservation. A European food and farming system based on agroecological principles can decrease emissions by up to 47%! Another <u>study published in Nature by Frank Eyhorn et al.</u> draws a similar picture. It concludes that organic drives sustainability in global agriculture and contributes to reaching the United Nations' Sustainable Development Goals (SDGs).

To showcase organic's contribution, IFOAM EU is taking part in several campaigns and activities – in the run-up to and after the elections. Together with several civil society organisations we are calling for an EU food policy to ensure the transition to more sustainable food systems. In parallel, we support the Fair Times campaign, urging the new Members of the Parliament are to establish a fair and sustainable production and consumption agenda benefiting people and the planet. IFOAM EU also supports the Good Food Good Farming campaign. It inspires citizens to get active before and after the elections and stand up for sustainable policies for better food and farming.

To engage with us and policymakers at local, regional, national and European level, our <u>European Organic</u> <u>Congress</u> from 20 to 21 June in Bucharest, Romania. We will also use that opportunity to launch an updated version of our <u>interactive infographic with organic market and production data</u>.



#### 1 NEWS FROM IFOAM EU WORKING FIELDS

# 1.1 Policy Organic regulation

### **Workshop in Bonn on Group Certification**

IFOAM – Organics International organised an international workshop on organic group certification requirements in Bonn 21-22 May 2019.

Around 35 experts from the EU and from outside the EU (Africa, South America, Asia, Australia) participated. Representatives of IFOAM EU and of the biggest EU control bodies which carry out certification outside the EU were also present. The initiative brought the organic stakeholders together to discuss and further strengthen and refine the requirements for organic group certification after more than 15 years of implementation all over the world.

The workshop was focused on the worldwide approach. The outcomes of the workshop will feed into the development of secondary legislation of the new EU organic regulation which will apply from 2021. While today group certification is only allowed in non-EU developing countries, the new EU organic regulation will allow certification of group of operators (group certification) also within the EU. The EU Commission and the EU member states will discuss the detailed requirements in the second half of 2019.

# **Common Agricultural Policy (CAP)**

#### Agriculture Atlas 2019 - Facts and figures on EU farming policy

The English version of the <u>Agriculture Atlas 2019</u> has been launched in Brussels. Besides mapping out country case studies the report illustrates the impacts of the current farming system on biodiversity, climate change, health, livestock farming and structural change.

# 1.2 Food, farming and environment

# IFOAM EU calls for an integrated EU food policy in open letter to potential European Commission Presidents

Developing an integrated EU food policy and appointing a European Commission Vice President responsible for ensuring the sustainability of our food systems. These demands were put forward by 32 associations in an open letter sent to the lead candidates for the role of European Commission President on 8 May.

In the letter we urge for a transition towards sustainable food systems which will "ensure the ecological transition necessary to tackle climate change impacts, water scarcity, soil degradation, biodiversity collapse, fish stock depletion, animal welfare, chemical pollution, and food waste and loss". To achieve this transition we urgently need an integrated common food policy and a new governance system.

The second demand of the letter focuses on the appointment of a European Commission Vice-President responsible for ensuring the sustainability of our food systems. The Vice-President should have a mandate to coordinate the efforts of the different Directorates impacting our food system. These include the DGs AGRI, CLIMA, COMP, EMPL, ENERGY, ENVI, GROW, MARE, SANTE, TRADE, and TRANSPORT.

The time for action is now if the EU wants to reclaim public policy for the public good, rebuild public confidence in the European project, and put the EU on track to meet the Sustainable Development Goals (SDGs) and the Paris Climate Agreement.

## It's official! The Unfair Trading Practices legislation is Directive (EU) 2019/633

Good news for our avid readers that followed the legislative process of the Directive on Unfair Trading Practices. The Directive has been published in the EU's Official Journal. This means that it is officially recognized under the following name and number: <u>Directive (EU) 2019/633 of the European Parliament and of the Council of 17 April 2019 on unfair trading practices in business-to-business relationships in the agricultural and food supply chain.</u>

As a small reminder, this directive prohibits 16 unfair trading practices, including late payments, and protects smaller suppliers from their bigger buyer counterparts. The European Commission's Directorate General for Agriculture has published a very well-made <u>guidance document</u> explaining the provisions of this directive. # Civil society calls for Commissioners that support future generations

<u>In a co-signed a letter</u>, IFOAM EU and 54 other civil society organisation ask the European Heads of State and Government to nominate candidates for the European Commission who will restore faith in the EU, provide a better future for all of us and for the planet.

The signees also request European policies, rules and standards that protect and safeguard well-being and health, ensure safety and freedom for people, and protect the climate and the environment. Europe needs to lead and support a just transition towards a sustainable economy and society for all people.

#### Update on IFOAM EU's work on access to land

Learning together about innovative land strategies to strengthen agroecology and the food sovereignty movement in Europe. That is the goal of Erasmus partnership that the European Coordination Via Campesina (ECVC), Terre de Liens, IFOAM EU, Urgenci, Eco Ruralis, the Transnational Institute, and the Real Farming Trust launched. The partners will organise a training seminar on local land strategies in September.

#### What would happen if organic farming and agroecology become the norm? Read the latest report

Transitioning European agriculture to agroecology by 2050 yields emission reductions from 40% to 47%, and benefits biodiversity, natural resources, adaptation, and health. These are the findings of the Ten Years For Agroecology (TYFA) study "Agroecology and carbon neutrality in Europe by 2050: what are the issues?".

The scenario demonstrates that climate and biodiversity can be improved simultaneously by changing agricultural practices. It is based on abandoning pesticides and synthetic fertilisers, redeploying natural grasslands and extending agroecological infrastructures like hedges, trees, ponds and stony habitats. It also looks at healthier diets with a reduced consumption of animal products, and a higher consumption of fruit and vegetables to sustainably feed 530 million Europeans in 2050. The study takes into account a 35% drop in production based on the lower production in agroecological systems.

The authors of the study are Pierre-Marie Aubert, Marie-Hélène Schwoob (IDDRI) and Xavier Poux (AScA, IDDRI). IFOAM EU commissioned the study.

#### The organic movement urges the European Commission to act now on new GMOs

Following years of debate about the legal status of new genetic engineering techniques the <u>European</u> <u>Court of Justice clarified the situation</u> in July 2018. It ruled that plants made from new techniques are GMOs and must be regulated as GMOs. The <u>organic movement welcomed this landmark decision</u>.

It is crucial that the European Commission and all members states now implement this decision. No new GMOs should be marketed without risk assessment, prior authorization and traceability. In that regard, the work of the next European Commission that will be appointed end of 2019 will be decisive. That is why IFOAM EU and 23 other organizations sent a <u>letter to all Spitzenkandidaten</u> on 17 May. In this letter the signees urge them not to give in to strong pressure from biotechnology companies and open the existing EU legislation developed to protect human health and the environment.

<u>IFOAM EU also co-signed a letter with 27 other organisations</u> sent to Vice President Katainen on 22 May. The current European Commission is currently establishing the work programme of the next Commission. The 28 signatories clearly remind the European Commission than any attempt to modify the current process-based GMO legislation and the seed legislation to exempt GMOs derived from new techniques would be unacceptable.

#### Connecting thematic networks as knowledge reservoirs: the EURAKNOS project

IFOAM EU is part of the Horizon 2020 <u>EURAKNOS</u> project. It aims to create a network that will strengthen the EU agricultural knowledge base by collecting existing knowledge and best practices from the other 29 existing thematic networks.

Professor Pieter Spanoghe from Ghent University is Coordinator of the project. He explains: "Thematic networks are a specific type of Horizon 2020 multi-actor projects which collect existing knowledge and best practices on a given theme (smart farming, poultry, crop protection, fruit, etc.) to make it available in easily understandable formats for end users such as farmers, foresters, advisers and others. EURAKNOS can be seen as the network of the networks that will analyse this knowledge to explore the feasibility of creating a modular database that makes this information more accessible to the farming community in a searchable and semi-standardized way."

Representing the organic movement at "Crop Protection: Education of the Future Generation" - IUPAC Congress

19-24 May 2019 Ghent, Belgium

The theme of the 14<sup>th</sup> IUPAC Congress on Crop Protection was: "Crop Protection: Education of the Future Generation". It gathered 1500 participants engaged in crop protection, from synthetic pesticides to biological pest control, from all over the world.

IFOAM EU Director Eduardo Cuoco was invited to join the panel discussion "Farming in 10, 20 and 30 years". On Tuesday 21 May he shared the vision of the organic movement for the future of agriculture and crop production. Eduardo stressed that we need a transition guided by organic principles towards a more sustainable agri-food system that is able to address socio-economic and environmental challenges. In 30 years, at least 50% of agricultural land will be organic instead of the 7% we have now. A crucial element is to reward practices that deliver public goods and make polluters pay for the cost of externalities that society bears. The ideal way to do this is incorporating true cost accounting into the economics of farming. Organic is the most promising option for the future of farming. It is a model



for sustainable farming and food systems that supports a culture of innovation based on holistic principles leading to more resilient and productive farming systems, greater biodiversity, better food quality, more appropriate processing and fairer supply chains.

# Agricultural projects learn from each other at the FarmDemo 22 May 2019 Brussels, Belgium

Farmers, advisors, researchers and policy-makers exchanged on the benefits of peer-to-peer learning through demonstration activities at the FarmDemo Conference. Participants had a chance to discuss and learn how to design better on-farm demonstrations and increase their impact. The tools and the findings of the three projects behind the <a href="FarmDemo platform">FarmDemo platform</a>— Plaid, NEFERTITI and AgriDemo — were shared and are also available online. Among them, a newly published Design Guide for on-farm demonstrations and a <a href="Matabase">database</a> where you can find a demo farm in your region or display your own farm.
